## Guidelines to participate as joint venture in proposed tender:

- (A) Separate identity/name shall be given to the Joint Venture firm.
- (B) Number of members in a JV firm shall not be more than two.
- (C) A member of JV firm shall not be permitted to participate either in individual capacity or as a member of another JV firm in the same tender.
- (D) The tender form shall be purchased and submitted only in the name of JV firm and not in the name of any constituent member.
- (E) The joint venture firm shall be required to submit Earnest Money Deposit (EMD) along with the tender in terms of the provisions contained in relevant condition(s) of EMD in uploaded tender documents.
- (F) One of the members of the JV firm shall be its Lead Member who shall have a majority (at least 51% share of interest in the JV firm. Foreign partner shall not be allowed as one of the members of JV. A copy of Memorandum of Understanding (MOU) executed by the JV members shall be submitted by the JV firm along with the tender. The complete details of the members of the JV firm, their share and responsibility in the JV firm etc. particularly with reference to financial, technical and other obligations shall be furnished in the MOU.
- (G) Once the tender is submitted, the MOU shall not be modified/altered/terminated during the validity of the tender. In case the tenderer fails to observe/comply with this stipulation, the full Earnest Money Deposit (EMD) shall be liable to be forfeited.
- (H) Approval for change of constitution of JV firm shall be at the sole discretion of the SMC / SSCDL Administration. The constitution of the JV firm shall not be allowed to be modified after submission of the tender bid by the JV firm except when modification becomes inevitable due to succession laws and in any case the minimum eligibility criteria should not get vitiated. However, the Lead Member shall continue to be the Lead Member of the JV firm. Failure to observe this requirement would render the offer invalid.
- (I) Similarly, after the contract is awarded, the constitution of JV firm shall not be allowed to be altered during the period of contract except when modification become inevitable due to succession laws etc. and in any case the minimum eligibility criteria should not get vitiated. Failure to observe the stipulation shall be deemed to be breach of contract with all consequential penal action as per contract condition.
- (J) On award of contract to a JV firm, a single Performance Guarantee shall be required to be submitted by the JV firm as per tender conditions. All the Guarantees like Performance Guarantee, Bank Guarantee etc., shall be accepted only in the name of the JV firm and no splitting of guarantees amongst the members of the JV firm shall be permitted.
- (K) Bidders of JV shall have to submit all the annexure drafted on appropriate amount of stamp paper, duly signed, stamped and with all information online with other documents. Hard copy of same shall be submitted at the time of the allotment of the work. In case the tenderer fails to observe/comply with this stipulation, the full Earnest Money Deposit (EMD) shall be forfeited and other penal actions due shall be taken against partners of the JV and the JV. This joint Venture Agreement shall have, inter-alia following clauses:
  - (i) **Joint and Several Liability:** Members of the JV firm to which the contract is awarded, shall be jointly and severally liable to SSCDL / SMC for execution of the project in accordance with General and Special conditions of the Contract. The JV members shall also be liable jointly and severally for the loss, damages caused to SSCDL / SMC during the course of execution of the contract or due to non-execution of the contract or part thereof.
  - (ii) **Duration of the joint Venture Agreement:** It shall be valid during the entire span of the capital and O&M works including the period of extension if any.
  - (iii) **Governing Laws:** The Joint Venture Agreement shall in all respect be governed by and interpreted in accordance with State and Central Government Laws.
- (L) **Authorized Member:** Joint venture members shall authorize one of the members on behalf of the Joint Venture Firm to deal with the tender, sign the agreement or enter into contract in respect of the said tender, to receive payment, to witness joint measurement of work done, to sign measurement books and similar such action in respect of the said tender/contract. All notices/correspondences with respect to the contract would be sent only to this authorized member of the JV Firm.

- (M)** No member of the Joint Venture Firm shall have the right to assign or transfer the interest right or liability in the contract without the written consent of the other members and that of SSCDL / SMC in respect of the said tender/contract.
- (N) Documents to be enclosed by the JV firm along with the tender.**
- (i) In case one or both the members of the JV Firm is/are partnership firm(s),** following documents shall be submitted online:
- a.** Notary certified copy of the Partnership Deed
  - b.** Consent of all the partners to enter into the Joint Venture Agreement on a stamp paper of appropriate value (in original)

- a.** Notary certified copy of resolutions of the Directors of the Company, permitting the company to enter into a JV agreement, authorizing MD or one of the Directors or Managers of the Company to sign MOU. JV Agreement, such other documents required to be signed on behalf of the Company and enter into liability against the company and/or do any other and on behalf of the company.
  - b.** Copy of Memorandum and Articles of Association of the Company authorizing the person to do / act mentioned in the Para (a) above.
  - c.** Power of Attorney (duly registered as per prevailing Law) by the Company authorizing the person to do/act mentioned in the Para (a) above.
- (iv)** All the members of the JV shall certify that they have not been black listed or debarred by SMC / SSCDL or any other Ministry/Department/PSU of the Govt. of India/State Government from participation in tenders/contract on the date of opening of bids either in their individual capacity as members of the JV or the JV firm in which they were/are members.
- (O)** The division of individual scope of work may be worked out mutually by the parties' internal responsibilities and liabilities:
- (a)** The division of individual scope of work may be worked out mutually by the parties but the party shall be jointly and severally liable to the employer for the whole work.
  - (b)** The parties specifically undertake to carry out their separate works in full compliance with the contract with the employer. Each party shall be responsible jointly and severally for consequences if any arising out of defective or delayed execution of works which falls within the individual's party's area of responsibility and/ or it has been caused due to acts and /or omission of the concerned party.
  - (c)** The parties jointly and severally agree to replace modify or repair any defect in their respective portions of works in accordance with the terms and condition of the contract with the employer.
  - (d)** The parties jointly and severally shall indemnify and hold harmless to each other against any claim made by the employer or any other third party for injury, damage, loss or expenses is attributed to the breach /non-performance of his responsibilities by the indemnifying party in accordance with the agreements and /or contract with the employer.
  - (e)** None of parties have joined in any other Joint Venture for the said works.
- (P) Financial matter:**
- (a)** Bank Account in the name of the Joint Venture shall be opened with any scheduled or nationalized Bank to be operated by an individual signatory as decided mutually by the Joint Venture partners.

- (b) All the partners shall be responsible to maintain or cause to maintain proper Books of Account with respect to the business of the Joint Venture firm as per the Indian Regulation Act and shall be closed at the end of the every financial year ending 31<sup>st</sup> march. None of the party shall be entitled to make any borrowing on behalf of the Joint Venture without express prior written consent of the other party.
- (c) Bank guarantee/ performance guarantee as asked elsewhere in tender documents for the application /execution of the work shall be provided jointly from a bank acceptable to the employer.
